CEO MESSAGE

Making Washington Work for You

Electric cooperatives are deeply connected to the communities they serve and are focused on meeting consumers' energy needs

today and into the future. Providing our consumers with safe, reliable and affordable power will always be our highest priority, but this requires much more than simply maintaining overhead power lines and other infrastructure.

It requires us to focus on what our elected leaders are doing in Washington to ensure they are acting in your best interest. Here are some of the legislative issues we're keeping an eye on in the nation's capital.

RURAL ACT

Congress created a problem for electric cooperatives when it made changes to the tax code in 2017 that inadvertently put cooperatives' tax-exempt status at risk if they receive government grants. This could stick cooperative members

with the cost of paying taxes unless Congress fixes the problem. Fortunately, there is a solution. Bipartisan legislation known as the RURAL Act has strong support in Congress, and we're working with lawmakers to pass this important piece of legislation.

WIND ENERGY

Recently, the U.S. Department of Energy selected the National Rural Electric Cooperative Association (NRECA)—our national trade association —to research small-scale, community-based wind energy solutions that can be deployed by electric cooperatives. This research, to be conducted in partnership with Pacific Northwest National Laboratory, is critical to helping cooperatives meet their members' desire for affordable renewable energy solutions.

CARBON CAPTURE

In response to public policy discussions in Washington about ways to reduce emissions, electric cooperatives are participating in cutting-edge research to capture and use carbon emissions to make commercial products. This work is under way at the Integrated Test Center, just outside of Gillette, Wyo., where researchers will strive to advance technologies and expand understanding of what's possible in this new arena.

The Opportunity to Represent Your Community

Members, elected trustees, and employees - that's who powers a notfor-profit electric cooperative.

Members elect representatives called trustees to serve on the board of trustees and to represent their best interests. Like you, they are cooperative members but with a special perspective. Trustees are local citizens who live throughout the Victory Electric service area They have the challenge of not only balancing the interests of other cooperative members, but also the community and the cooperative business, and have to make business decisions for all.

The business and affairs of the cooperative are directed by the board of trustees, whose primary function

is planning and policy oversight, establishing the long-term objectives of the cooperative, and providing resources to meet those objectives. Board members work closely with the CEO and senior staff to review progress, ensure accountability, make strategic decisions, and stay current on an increasingly complex business.

The cooperative territory is divided into districts, all of which are represented by a trustee. Trustees are elected at the annual meeting for threeyear terms of office. A commitment to the cooperative board is also one to the community. Each trustee holds the responsibility of representing their cooperative in the public eye.

Duties of an elected trustee include:

attending monthly six-to eight-hour board meetings, board training events, and some travel is required. Trustees attend outreach events, serve on additional board subcommittees, attend trainings, and listen to those in their district. They act as liaisons between the greater membership and the cooperative management team and employees to make sure the needs of the members are met. Trustees also ensure all perspectives are presented and discussed when making cooperative business decisions.

For the orderly operation of an electric cooperative, the board of trustees must understand, be dedicated, and ultimately fulfill their responsibility to the members and the cooperative.




RURAL BROADBAND



Stay Safe in Your Home: Five Space Heater Safety Tips

As temperatures drop this winter, many will look for supplemental heating sources for their homes. Space heaters can be a good alternative for those who want to warm one area of their home without turning up the thermostat on the central heating system. However, according to the National Fire Protection Association, space heaters are responsible for 32% of house fires. If you plan to use a space heater in your home this winter, review these tips from Victory Electric to keep you, your family and your property safe. Stay safe this winter with these tips.

► Materials— What are the components of your space heater made of? Parts like metal grating can be hot to the touch and may burn anyone who gets too close. Make sure you purchase a heater that is cool to the touch and has guards over the coils just in case little fingers get too close.

▶ Placement — While it can be tempting to place a small heater on a shelf so it is not in the way of pets and children, it is safest to leave the heater on a level, nonflammable floor. Placing the space heater on the floor can keep it from falling over, preventing fire hazards. Also, remember space heaters and bathrooms are not a good combination unless the heater is designed for bathroom use.

Moisture can damage the heater. The most important rule about space heater placement is the three-foot rule. Whether you are using the heater in the bedroom, living room or kitchen, space heaters should always be kept three feet away from flammable materials and out of the

way of children and pets.

- ► Special Features Does your space heater have an auto shutoff function if tipped over? Auto shut-off can be a lifesaver. If you currently own a space heater without auto shut-off, consider purchasing a heater with this important safety feature.
- ► Cords—You should never use an extension cord when plugging in a space heater as it can cause overheating. The space heater should be plugged directly into a wall outlet, and should be the only thing plugged into the wall outlet. Also make sure cords aren't in a high-traffic area so they are not a tripping hazard.
- ▶ **Use** Never leave a heater unattended while in use. If you are leaving your home or going to bed, unplug the space heater.
