Victory Linemen Battle Blizzard Conditions

Winter Storm Finn blanketed western and central Kansas with heavy snow Jan. 8-9, while wind gusts of over 60 miles per hour caused blizzard conditions and numerous power outages. The system brought rain, sleet, graupel (small, soft hail or snow pellets) and even thunder snow as the temperature

dropped and the system moved east to northeast across Victory Electric's service area.

By the evening of Jan. 8, the Kansas Department of Transportation had closed almost all highways in western Kansas because of the dangerous travel conditions. The blizzard also affected Victory Electric crews' ability to restore power because of limited to zero visibility, drifting snow, slick roads and vehicles stuck in roadways.

Linemen sheltered in place until visibility improved and it was safe for them to resolve the


many power outages caused by the storm. They had assistance from area farmers, who towed some Victory Electric trucks through deep drifts with tractors so they could access remote locations.

Victory Electric would like to thank Daylight Donuts and Miss Kitty's Café for providing food to our line crews! We also appreciate all the many kind words and messages of support we received throughout the storm and for members' patience as Victory crews worked in adverse conditions to safety resolve over 7,000 outages in our service area.

BACKGROUND: Because of heavy snow and wind gusts on Jan. 8 that caused whiteout conditions, Victory Electric crews sheltered in place as needed until visibility improved and they could safely continue working.

Energy Costs and Your Victory Electric Bill

While inflation and high prices for many goods and services continue to affect consumers' wallets, Victory Electric knows cooperative members want to save money wherever they can. As a not-for-profit electric cooperative, Victory Electric strives to provide reliable electricity at fair rates and to control costs as much as possible.

The Energy Cost Adjustment (ECA) is a pass-through variable charge or credit used to recover variable energy costs. The ECA changes from month to month based on wholesale pricing and the market rate for energy. The ECA allows the cooperative to respond to market fluctuations by adjusting bills either up or down to account for variable power supply costs. These variables determine how much money our power supplier incurs or saves in the process of generating power, including fuel costs like coal and natural gas, power purchases and the cost of transmission to deliver the power to Victory Electric's system. Note that Victory does not profit from increases in the price of wholesale energy.


When the cost of wholesale power decreases, the ECA also allows Victory Electric to pass the savings on to our members as a bill credit. This happened throughout 2023. Victory Electric members received a credit for the ECA every month last year.

Natural gas prices in 2023 were the lowest since mid-2020 and were about 62% lower than the average price in 2022, according to the U.S. Energy Information Administration. Overall temperatures were also milder in 2023 than in 2022.

In 2022, the average annual price of natural gas surged to its highest level since 2008. Russia, a chief exporter of natural gas, invaded Ukraine that year, causing fears about natural gas shortages and increased demand for gas supplies outside of Russia. Record heat drove up electric usage, and extreme to exceptional drought in many parts of the U.S. further increased demand for energy. In 2021, Winter Storm Uri sent natural gas prices soaring, and supply chain issues and economic strain still lingered from the COVID-19 pandemic.

Factors like these affect energy costs and are outside of Victory Electric's control. While energy markets, weather,

natural gas supplies, prices and government energy policies are constantly fluctuating, Victory Electric continues to focus on the factors that are under our control as we provide safe, reliable and affordable power. We all have some control over the amount of energy we use, and we will continue to share ways to help you save energy and save money.




Victory Electric's energy rates (charges for poles, transformers and metering — also referred to as wire charges) have remained the same since 2017. The energy charge on a member's bill is the cost for the total amount of energy used in a billing period.

Based on rate data from the U.S. Energy Information Administration, Victory Electric continues to provide some of the lowest electric rates in Kansas. Victory's average residential price, 13.44 cents per kWh, is the third lowest among the Kansas-based electric cooperatives. It is also lower than the Kansas average rate for cooperatives (14.8 cents/kWh) and the Kansas average rate for all Kansas electric utilities (13.99 cents/kWh).

Victory Electric believes in developing the potential of today's youth to become tomorrow's leaders. To provide opportunities for building these skills, each year Victory Electric invites juniors from its cooperative service area to apply for all-expenses-paid trips to the Electric Cooperative Youth Tour in Washington, D.C., and the Cooperative Youth Leadership Camp (CYLC) in Steamboat Springs, Colorado.

Robinson and McDonald will attend the Youth Tour June 13-21, and Stimpert and Koehn will attend CYLC July 12-18. The four winners will also receive a \$500 scholarship following their high school graduation. This year, Victory Electric asked candidates to create a short video sharing energy-efficiency tips and explaining why saving energy is important. A panel of judges selected the winners after evaluating the candidates' applications, résumés, videos and in-person interviews.

"We're proud of the students who applied, and we enjoyed seeing the creativity shown in their energy-efficiency videos.

The annual youth trips reflect Victory's commitment to community and youth development, and we know this year's winners will represent the cooperative well in their travels this summer," said Victory Electric Vice President of Communications Chanda Schulte.

Youth Tour attendees will meet with state and national legislators in the nation's capital and build connections with thousands of high school students from across the country. The educational experience includes tours of Smithsonian museums, visits to the White House and other historic sites and monuments.

CYLC participants will learn about the electric cooperative industry through hands-on sessions, raft on the Colorado River and tour a power plant. Nearly 100 students from electric cooperative communities in Colorado, Kansas, Oklahoma and Wyoming are expected to attend the leadership camp this summer.
