The Lightner Community Spirit Scholarship is designed to recognize students who have demonstrated academic success, as well as show a commitment to their community.





Victory Electric crew chief Joel Daniels will retire in January after serving Victory Electric for 22 years.

Daniels was hired at Victory Electric in April 1996 as a journeyman lineman.

"Joel's dedication and service through the years means a lot," said Ryan Miller, vice president. "We hope he has a relaxing and enjoyable retirement."

Daniels began his career as a lineman after

completing Pratt Community College's line program in 1985. He then worked for CMS Electric in Coldwater, Kansas, prior to joining Victory Electric.

The Kalvesta area native wanted to be a lineman after some of the men in his family influenced him.

"My cousin is a lineman for Prairie Land Electric Cooperative and both my father and father-in-law were linemen," Daniels said.

Daniels was promoted to crew chief in 1997 and has worked with and mentored a lot of young crew members. In 2017 he participated in the 2017 International Lineman's Rodeo in Bonner Springs, Kansas.

"I've seen a lot of young linemen come in and make careers at Victory Electric," Daniels said. "That's my favorite part about this career--appy people. That's why we do what we do, to keep members happy."

With more than 30 years of experience, Daniels also knows there are some hardships with the job, too.

"The weather is the biggest challenge. I know a lot of men say that, but it really is," Daniels said. "The nights are late and long when you're trying to get the lights back on for members."

As a family man, Daniels and his wife have four children and 17 grandkids between here and Missouri. He also plans to play guitar and write worship music.

"We will travel a bit more to see the grandkids and I will have time to play guitar, which I like to do a lot," Daniels said. "It's been a good career and I've learned a lot, but retirement will be nice, too."
