
Victory Electric is sponsoring five local high school juniors to participate in our Youth Tour programs.

### Los Bienes del Consumidor Suben de Costo

La demanda popular y la escasez impulsan el costo de las necesidades cotidianas que suban. Algunos cambios-como el precio de llenar de gas el tanque de su auto-son evidentes para cualquier persona que conduzca. Otros aumentos en el supermercado son más sutiles pero aún impactan a la familia. Compare el incremento de un promedio de gastos en hogar para ver cómo aumenta la electricidad.

El precio de un galón de gasolina sin plomo subió un 11.1 por ciento en un promedio de entre el 2002 y 2012, de acuerdo con los EE.UU. Oficina de Estadísticas Laborales. El costo de una docena de huevos aumentó un 7.8 por ciento. Los Panaderos han visto el precio de la harina aumentar un 5.7 por ciento, y las manzanas sintieron el crujido de un salto del 4.8 por ciento, cada año.

El costo de energía eléctrica creció a un ritmo más lento-3.2 por ciento al año, en promedio. Los EE.UU. Administración de Información Energética (EIA) informa a los propietarios de viviendas en todo el país pagan un promedio de 11.7 centavos de dólar por kWh. 

### **Costs for Consumer Goods Climb**

Popular demand and short supply drives the cost of everyday necessities higher. Some price tag changes—like the cost to fill your gas tank-are obvious to anyone driving down the road. Other increases at the grocery store are more subtle but still impact your family's bottom line. Compare the average price increase of a few household expenses to see how rising costs of electricity stack up.

The cost for a gallon of unleaded gasoline shot up an average of 11.1 percent per year between 2002 and 2012, according to the U.S. Bureau of Labor Statistics. Eggs don't go over easy—the cost for a dozen eggs increased 7.8 percent. Bakers watched the price of flour rise 5.7 percent, and apples felt the crunch with a jump of 4.8 percentevery year.

The cost of electricity grew at a slower pace-3.2 percent a year, on average. The U.S. Energy Information Administration (EIA) reports homeowners across the nation pay an average of 11.7 cents per kWh. In Kansas, electric cooperatives keep costs even more affordable—the average price for power is 10.7.


Unlike eggs or apples, electricity is a 24-hour-a-day commodity. Despite energy efficiency advancements, the average household uses more electronoic gadgets-and

needs more power to operate them-every year.

In the past 30 years, the amount of residential electricity used by appliances and electronics has increased from 17 percent to 31 percent according to the Residential Energy Consumption Survey by EIA. More homes than ever have major appliances and central air conditioning. Digital video recorders (DVRs), computers, and multiple televisions are common.

Victory Electric works hard to keep your electricity safe, reliable, and affordable. But you play a role in the price of your power.
